WE PROVIDED ADVANCE INFORMATION TO THE GOVERNMENT OF INDIA ON PAFF'S PLANNED TERROR ATTACK IN THE LAST MONTH OF NOVEMBER. UNFORTUNATELY, THE GOVERNMENT OF INDIA WERE UNABLE TO STOP THE TERROR ATTACK IN RAJOURI DISTRICT ON 22 NOVEMBER 2023.</div> <div>Dear Sir,</div> <div>I want to inform you that we provided confidential information via letter reference No. DL/1561/09/23 Date - 19.09.23 to the Prime Minister's office, Ministry of Home Affairs, NSA Shri Ajit Doval and Mililatry Intelligence about the PAFF Pak-based terrorist organisation that has planned to attack J&K in the last month of November. (Copy Attached)</div> <div>I regret to write that PMO didn't take any action on our information of the terror attack in the last month of November. If the PMO is seriously concerned about that information, maybe we can save the five Para (SF) Commandos soldiers' lives.</div> <div>When we file the RTI in PMO, ask what action PMO has taken. CPIO Shri Pravesh Kumar's reply to us, "Applicant is based on assumption and in the form of roving enquiry and does not come under the definition of information under section 2 (f)".</div> <div>As per the RTI reply by CPIO Mr Pravesh Kumar, it is clear that the PMO didn't forward it to security agencies and disposed of it on an assumption basis.</div> <div>2. We provided advance information on the terror attack by PAFF in the last month of November 2023.
