AS THE GOVERNMENT RTI REPLIES, THE GOVERNMENT OF INDIA IS NOT AWARE OF CHINA STUDIES, WHICH IS NEGLIGENCE OF THE GOVERNMENT.

I want to inform you that we sent a confidential report on the above subject matter to the Prime Minister of India with letter Ref. DL/1536/01/2023 Dated 18.01.2023 and President of India with letter Ref. DL/1535/01/2023 Dated 18.01.2023.

Unfortunately, the government of India didn't take any action on the above subject matter. When we filed an RTI in the President's secretariat for asked What action the President of India had taken, they replied that this report forwarded this report to the Ministry of Home Affairs for appropriate action.

After that, I filed an RTI in MHA, and MHA replied that, As per MHA record, it is informed that the letter dated 19/04/2023 forwarded by the President's secretariat has not been received / traceable in this ministry.

This type of negligence in the National Security matter by the Government of India makes clear that the " Government of India and BJP Party are supporting China".

Please take seriously on national security matters and take strict action on the China studies centre.
