We urge the Prime Minister's Office to take action to safeguard India's national security and address the issue of espionage activities in the country. We have identified several individuals, including former military officers, former NSA Shivshankar Menon, and NSA Sh. Ajit Doval, who has close connections to CICIR."</div> <div>3. MODUS OPERANDI OF CICIR. The China Institutes of Contemporary International Relations is the cover identity of the 11th Bureau of the Chinese MSS. It is a set of research institutes used as a front to influence foreign diplomats and academics and collect intelligence. Compile research reports on a wide range of topics, including global and regional political, economic, diplomatic, military, and social issues, and submit research results to relevant government departments.</div> <div>4. Hu Shisheng and Wang Jun are members of CICIR, they submitted a report to their departments regarding the Gol :- 1. Fundamental Pursuits of India’s National Security Strategy. 2. Three Origins of India’s National Security Strategy. 3. The Concrete Practice of Indian National Security Strategy .</div> <div>5.
